### Minutes of the November 15, 2020 Voters Assembly

November 15, 2020

#### 70 Attendees

The meeting was called to order at 11:54 a.m. by Bill Fuller, Congregational Chairman. Pastor Pohland opened with prayer.

New members were welcomed by the assembly.

Bill explained why there were no minutes from the previous Voters meeting. A copy of the agenda from that meeting is included in the information packet.

It was announced that Phyllis Draheim will retire effective December 31, 2020. During her 38 years at Faith she has served as Music Director, played the piano and organ, and directed the choir. For 18 years she also served as church secretary. She has been and will continue to be a loyal and faithful servant of the Lord.

The Long Range Planning Committee is currently on hiatus. They will resume their work at a later and safer time.

Leon Buck explained what a columbarium is and why it could be important for Faith Lutheran Church. It is a special place on church property for burial urns. At this time the plan is to start it in the Meditation Garden. So far \$30,000 has been pledged for the columbarium. It is not a budget item and will be paid for by donations. The assembly approved proceeding with detailed planning, including legal and regulatory ordinances and plans for continued maintaining of the columbarium.

Capital Campaign V is in its second year. Voters approved forming a Capital Campaign VI committee. That campaign will run from January 1, 2022 through December 31, 2024. The Church Council will find members for this committee. Bill reviewed the weekly Financial Status update that is emailed to members with the daily minute prayer on Thursdays. He also reviewed the 2020 budget performance and assured the congregation that designated funds would only be used for the designated items.

The proposed 2021 Budget reduces external mission giving, such as giving to Synod and District, by 10%. The worship budget was reduced because we are not printing bulletins, ordering new music, etc. We are eager to restore these funds if/when there is an increase in giving. The Voters approved the 2021 Budget.

Preschool stopped in April because of COVID-19. It was unable to open in September. They hope to reopen in January with limited classes and teachers.

Many of our Boards had so much to do this year. Some made plans for events and then had to cancel. It has been a very unusual year. The staff had so much to learn about putting a worship service online. They have done incredible work getting the services online as well as Children's Message and Bible Study.

Bill presented a slate of candidates for Church Council and Board Chairs. The slate was approved by the Voters.

Pastor Crowe closed with prayer. The meeting was adjourned at 12:50 p.m.

#### Pastor Walt Pohland's 2021 Spring Ministry Report

#### Thy will be done.

Sometimes, "Thy will be done" is the hardest petition to pray. In the selfishness of sin, even dedicated Christians may be tempted to pray otherwise, asking God to adopt their will as His own rather than kneeling before God in humility and trusting that His will is always altogether holy.

In the Small Catechism, Luther reminds us that God's will is done "when He breaks and hinders every evil plan and purpose of the devil, the world, <u>and our sinful nature</u>, which do not want us to hallow God's name or let His kingdom come; and when He strengthens and keeps us firm in His word and faith until we die." (underlining added.) Politely we nod our heads in agreement, cheering for God as He thwarts Satan and the world; but perhaps we are sometimes less enthusiastic when God works to thwart Satan and the world in <u>us</u>. We rejoice to hear Jesus say, "My Father's will is that <u>everyone</u> who looks to the Son and believes in Him shall have eternal life, and I will raise him up at the last day." We cringe a bit to hear the Bible say, "It is God's will that <u>you</u> should be sanctified." (John 6:40 and 1 Thessalonians 4:3; underlining added.) That "you" can be awfully personal, especially when it means we have to say "no" to an appealing temptation, curb a demanding appetite, or set self aside for the blessing of an enemy (or even a friend,) or say "yes" to an unwelcome interruption, take on an uncomfortable responsibility, or set aside a personal goal or dream in response to a different calling from God.

How good it is for us to hear Jesus, our Savior, pray, "<u>Not</u> My will but Yours be done." (Luke 22:42; underlining added.) There is much for us to learn in that "not." For example, it has apparently not been God's will to bring the COVID-19 pandemic to a miraculous, quick, convenient, and painless end. It very much remains His will, however, that even in the midst of pandemic His children live uncomplaining, confident, joyful, faithful lives of commissioned discipleship that make the love of Jesus real to others. The sinful nature will surely protest, but faith will grow and mature as it learns to pray with Jesus and submit trustingly when the Father says "no" or "not now" or "not yet."

In His good and gracious will, despite the coronavirus and its many complications, God continues to build His kingdom, here at Faith and across the globe. By the Lord's mysterious doings, Faith's on-line ministry of daily prayers and weekly worship services is reaching beyond Georgetown, touching the lives of people we may never meet in person but with whom we share the gospel of God's

love. Our in-person services are growing in attendance; and we continue to explore new avenues of outreach into the larger community. Kingdom-building may seem daunting, confusing, frustratingly slow, or, just the opposite, breathtakingly fast, but it is always God's own work. That He calls and equips us to be part of it is pure grace.

Echoing and amplifying the petition, "Thy will be done," the benediction that closes the book of Hebrews and that the Church hears and embraces throughout the Easter season speaks of God's will and work: *May the God of peace, Who through the blood of the eternal covenant brought back from the dead our Lord Jesus, that great Shepherd of the sheep, equip you with everything good for doing His will, and may He work <u>in us</u> what is pleasing to Him, through Jesus Christ, to Whom be glory forever and ever. Amen. (Hebrews 13:20-21; underlining added.)*

# Jonathan Loesch - Director of Christian Education

May 16, 2021 Voters Assembly

#### VACATION BIBLE SCHOOL

- Austin and I, along with the help of other adult & youth volunteers, will be putting on TWO separate VBSes this summer! One for our own Faith children/families and our community, June 7-11 (on Faith's campus), and one specifically for the children and families at the Boys & Girls Club of Georgetown (on their campus), August 2 -6. Registrations for our June VBS began in April.
- The curriculum will be "Rainforest Explorers: Jesus Leads the Way" (CPH)
- Early recruiting and training volunteers for these two experiences will be key to a successful, meaningful, and fun VBS!
- The Board of Education, at our next meeting, will need to weigh in on how we will all need to work together and pool our resources to make this happen!

#### **CHILDREN'S SUNDAY SCHOOL**

- In-person Sunday School continues Sunday mornings from 10:15–10:50 a.m. for families with children ages 2 thru 5th grade in the Activity Center. We are currently using *Enduring Faith* (CPH Unit 5) as our curriculum. Jonathan, Jennifer Bullock, and two CTX teacher-ed students serve as our leaders.
- It is our hope, in the not-so-distant future, to break off into two groups for more optimal and age-appropriate learning. The younger group (ages 3 6) would remain in the Activity Center, while the older group (ages 7 10) would go upstairs to the largest room ("the cave"), C-203.

#### ADULT BIBLE CLASSES

- Pastor Pohland continues to record and lead a Bible study for online participants every Sunday morning based on the Gospel reading from the lectionary series.
- Dedie Wright now leads the parents in in-person Bible studies based on <u>Luther's Small</u> <u>Catechism</u> on Sunday mornings between 10:15–10:50 a.m. The Bible class is also live streamed for those folks wishing to participate at home.
- It is the hope to add one or more adult Bible class on Sunday mornings, starting in June. We are looking at three candidates for future Bible class leaders.

#### **ROCK HOUSE MINISTRY**

- Austin and I continue to deliver DVDs, of our worship services and children's messages, to our Rock House friends (in all 14 of their group homes spread around Georgetown) twice a month.
- Our Rock House ministry staff at Faith has been faithful in writing birthday cards for the residents and making appropriate contacts with them as well.
- Last month Austin and I delivered thank-you cards, gift cards, (or chocolate bars) as part of our "Rock House Staff Appreciation Day" for all the caregivers/house managers and admin workers of Rock House in Georgetown. We were blessed to be able to do this through a Thrivent Action Team grant that was recently acquired. It was so gratifying and fun to surprise them with this well-deserved token of our appreciation! All the recipients were very grateful for the cards and gifts!
- The residents of the Rock House homes are looking forward to the day they can come back to church and worship at Faith again. In speaking with the admin folks at Rock House, this will hopefully begin happening in late spring of this year. There is one big caveat, however. We, as a congregation, will have to provide transportation to and from the church for any resident wishing to attend. Rock House will provide their vans and busses, but we would have to find the drivers each Sunday. They would train and pay the drivers, but they would have to come from within our congregation. We will be discussing this issue, along with some other possible solutions, with the Board of Education at our next meeting.
- One idea, in regards to reaching our RH friends right away, is to provide a joint worship & Sunday School experience at the RH Day Hab in town and conduct a service and Bible study for them there.

#### **OUTREACH KIDS CLUB: "VIP"**

- Since the Boys & Girls Club is only open on a limited basis, and volunteers are not allowed in, Austin and I have found a few ways to still be able to minister to the kids and staff there:
  - Recorded (on DVD), lessons for B & G Club leaders to present to the children there.
  - Provided supplies and materials for the Club as requested by the director.
  - Kelly, the director, is working to get us back to in-person meetings with the kids at the club.

#### CHILDREN/FAMILY MINISTRY

- There were 86 Easter goodie bags distributed to all the children who attended any of the three services on Easter Sunday. We also be continued the children's tradition of the Flowering of the Cross on Easter Sunday both inside and outside!
- Our bimonthly *Happy Times* and quarterly *My Devotions* devotionals (for use in family's homes homes) have been set out on tables in the narthex for families to pick-up when they come for inperson worship.

- Austin and I continue to record the weekly Children's Message/Chapel together for families, children, and children of all ages! I am so very appreciative of Adam for recording and Austin for doing all the editing of these messages every single week!
- Bibles and other print resources for children and families are being made available at the church. For those not able to come to church, I deliver or mail to them.

#### NURSERY CARE MINISTRY

The nursery is back! We are once again offering nursery care for children (infant thru age 3) on Sunday mornings during the worship and Sunday School times. Amy Cox, Kassie Perez, and (just-added) Danielle Peartree are our nursery attendants.

#### **CRADLE ROLL**

Joan Surko, our Cradle Roll Coordinator, continues to send out Cradle Roll packets to families who have recently had a child baptized here at Faith.

#### **CONFIRMATION MINISTRY**

#### FAITH LUTHERAN PRESCHOOL

- We currently have 22 children enrolled at FLP with a new student to start next month.
- Registration for fall classes is now open to the community. Three classes for the fall are almost full. We plan to add more classes (and teachers!) as more children enroll over the summer months.
- Our director, Sabrina Skelton, is an impactful leader and hard worker who loves the children, families, and staff at Faith!
- Thank you AGAIN for your prayers and support for Faith Lutheran Preschool!

# **BOARD of TRUSTEES**

#### **MEMBERSHIP:**

Membership to the Board of Trustees currently stands at 15 members from the congregation. We are in need of 8 to 10 more members to conduct our business properly.

#### **Protocol:**

Trustee meetings are conducted on the second Tuesday of each month, if needed, beginning at 7:00 P.M. in Room B-120.

#### **Board procedures**

- The Board Of Trustees employs 16 local vendors to perform maintenance/repair work not otherwise performed by the Board teams. The church saves thousands of dollars using the volunteer work of our board members.

- Work requests come to the Chairman and are assigned to a team to do the work or contact one of the vendors.

- Utilities and budget balances are monitored and reported to the Board by the Trustee Chairman.

- The board rotates between members to clear sidewalks, open doors, turn on lighting and necessary A/C adjustments every Sunday morning and verifies that doors have locked and lights and A/C are turned off every Sunday after services.

#### **Accomplishments**

- During the period, October 2020 to April 2021 we have repaired sprinkler system leaks
- Many small plumbing repairs were made around the campus.
- Individual trustees removed some of the frozen plants and will continue as time allows. Some plants are slowly recovering.
- Trimmed tree limbs near buildings and removed storm damaged limbs
- Set up replacement of all shingle roofs on campus, plus sealing the roof of the Activity Center.
- Replaced many light bulbs around the campus.
- Trustee mowing of the back acreage not covered by landscape contract.
- Replace A/C filters as scheduled.
- Replaced one A/C unit for the church office area.
- Repaired several more units.
- New large A/C unit for north side of sanctuary is ordered, must be made to fit our space.
- Trustees are involved with planning emergency management program.

- Touch up painting to some walls was done.
- Ramps on sidewalks have been repainted.
- The trustees monitored the buildings during the winter storm daily to verify heat was on and water dripping to control damage to the buildings.
- Replaced the water heater in the activity center.
- One interior door lockset was replaced in activity center.

- 1. Frugal management of the budget.
- 2. Pursue active recruitment efforts for the Board membership.
- 3. Encourage congregation participation on scheduled work days.
- 4. Make workday efforts more conducive for congregation participation.
- 5. Maintain timely communication with council, Elders, office and Trustee Board.
- 6. Conduct Trustees meetings in accordance with Robert's Rules Of Order.
- 7. Maintain a flowing agenda for scheduled meeting

### FAITH LUTHERAN PRESCHOOL

Faith Lutheran Preschool re-opened on Thursday, January 7, 2021 with all COVID safety precautions in place. After delaying our planned opening in September, three teachers, one aide, and an Interim Director began teaching nineteen 18 months, 2's, 3's and 4's in self-contained classrooms for seventeen weeks, Tuesdays and Thursdays, 8:30am-2:30pm.

As of March 31<sup>st</sup>, we currently have 20 children enrolled with another child starting in April.

We are now registering for fall semester 2021-22, and have 24 children with room for several more ages 18 months to Advanced Kindergarten Prep. We will be adding more teaching staff and additional classrooms as our enrollment grows over spring and summer. Faith Lutheran Preschool will be in session on Tuesday-Friday starting August 31, 2021 and ending May 20, 2022. Parents may choose either a 2-day program or 4-day program for their child. We are grateful for all the prayers and financial support Faith Lutheran Preschool has received, and we look forward to continuing our mission of providing high quality Christ-centered teaching to our young children!

#### **Bags to Mats**

- The Bags to Mats Ministry has resumed meetings as of February 2021.
- An announcement was made in January to find people to crochet, and three ladies were interested in learning how to crochet the mats. We met in February for instruction and again in March for follow up with great success.
- We meet every other Friday at 10:00 a.m. at the church. Anyone interested in becoming involved in the Bags to Mats Ministry is invited to join us.

#### The Caring Place

The mission of The Caring Place is to provide for the basic human needs of all people in our community in a welcoming, respectful, and caring way.

We have had to make a lot of changes at The Caring Place to adapt to COVID-19 challenges:

- Shifting food programs to a drive through format
  - Currently, we provide food in a drive thru format at 2000 Railroad Ave. every Tuesday and Thursday from 8:30 a.m. 10:30 a.m. Each vehicle receives approximately 48 pounds of food. The Fresh Food for Families program continues to serve fresh produce on the 1st, 3rd and 5th Monday of each month from 9:00 a.m. 10:00 a.m. Both of these programs are open to everyone.
- Creating financial assistance by phone
  - The Caring Place offers financial assistance with basic needs including rent, mortgage, utilities, transportation, emergency dental, prescription assistance and COVID-19 related crisis. All financial assistance is handled remotely Monday Friday, 9:00 a.m. 4:00 p.m. Call to 512-943-0709 for assistance. Our service area includes Georgetown, Andice, Bartlett, Granger, Florence, Jarrell, Jonah, Schwertner, Walburg, Weir and the portion of Hutto that lies within GISD.
- The Caring Place thrift stores are open at reduced hours
  - The Shops at The Caring Place at 2000 Railroad Ave. is open Monday -Saturday, from 11:00 a.m. 4:00 p.m. and Second Helping at 3700 Williams Dr. Tuesday Saturday, from 10:00 a.m. 4:00 p.m.
- Donating clothing, furniture and other household items
  - Donation drop offs are currently accepted every Monday from 11:00 a.m. 2:00 p.m. Our truck is also available to pick up large items.

The biggest change remains in the significantly reduced number of volunteers who are vital to normal operations. We are slowly scaling up and bring back our volunteers.

#### Faith in Action Georgetown

Faith in Action Georgetown (FIAG) provides services at no charge to non-driving seniors age 65+ who cannot afford a vehicle and related upkeep, and who live in their own homes in Georgetown or its ETJ. FIAG's mission is to help seniors maintain their independence and quality of life by providing transportation and other services. While transportation was interrupted by COVID-19, FIAG implemented a buddy program for social connections and check-ins as well as assistance with online grocery orders, curbside pick-up and/or delivery. The Go-Van-Go program to local grocery stores returned in January with safety protocols including reduced ridership to support social distancing. Awareness and flexibility are key as the organization recognizes that the landscape is ever changing.

Volunteers continue to be of great need as we have experienced a vast reduction since our average age is 68. Our volunteer drivers are part of the COVID-19 vulnerable population or they are caring for someone who is immunocompromised. To minimize volunteer burnout, FIAG has limited rides to once per week to medical destinations only. First quarter 2021, FIAG had 565 seniors enrolled for services and 176 trained volunteers. FIAG welcomes promotion of volunteer opportunities and appreciates the continued funding to assist our Georgetown seniors.

# **GIFT & ENDOWMENTS COMMITTEE MAY 2021 REPORT**

#### Financial Balances as of March 31, 2021

#### Church Worker Scholarship Endowment Fund \$127,981.35

One of the blessings that Faith has received is that some of our members have gone on to be church workers. They have completed university coursework, field training, and now serve in various church positions around the country.

The university coursework is typically completed at a Concordia University campus. As many of you know, a university education is not inexpensive, and an education at a private university is even less so. This Church Workers Scholarship and Endowment Fund provides scholarships to those who are earning a degree and intend to pursue a career in church work. This fund has helped make it possible for over a dozen students to continue their education and become church workers. There have been situations when a scholarship from this fund has been the difference between continuing an education or suspending study.

No distributions were made for the current school year.

#### **Restricted Private Member Memorial Endowment Fund** \$8,812.06

# Show Faith Works '21

(Connecting the Disconnected)

#### Overview

Without question, 2020 was a hard year on everyone. It was the year that everything changed. The normal rhythms and routines of life were disrupted and replaced with quarantine and isolation for most. Unfortunately, it didn't take long for people to establish new habits. For a lot of Christians, especially those who made it to church once a month or so, that meant the "new normal" is life disconnected from the Church. For non-Christians, i.e., the rest of the world, it is even worse. During the pandemic the world saw the Church not as a place to run to and to call out to God, but as another organization (much like a restaurant or a gym) that should be regulated for the protection and wellbeing of all people. In other words, the "new normal" for the world is also a life completely disconnected from the Church. While this might sound like the pandemic has dealt a fatal blow to the Church, the reality is that Jesus has directed His Church for over 2,000 years now, and this pandemic is by no means the worst world crisis the Church has ever faced. One only has to look at the history of the Early Church to realize that Jesus' Great Commission *to make disciples* (Matthew 28:18-20) is in scope during good times as well as bad times. In fact, it's in the bad times that we often see Jesus bring new life and vitality to the Church for the world.

One such time, that is extremely instructional for us today, comes from the time that Paul planted a new church on the island of Crete, somewhere around AD 57. Around AD 65, Paul assigned Titus to pastor the church. Unfortunately, the church had a lot of problems internally and externally and the young Titus was struggling to hold it together. The congregation was on a path of becoming disconnected, and the world was completely disconnected and even turning against the church. When Paul hears about the troubles, he writes a letter to Titus to first encourage him, to give him advice on how to put things in order (Titus 1:5), and to give him a strategy to encourage the church, especially in this hard time, to be the church. Six times, in three short chapters, Paul exhorts Titus to show the congregation how to do good works (Titus 1:16, 2:7, 2:14, 3:1, 3:4, and 3:14 ESV).

In Titus 3:4-8, Paul emphatically states that "God saved us, **not because of works** done by us in righteousness", but exclusively "according to [God's] own mercy, by the washing of regeneration and renewal of the Holy Spirit, whom He poured out on us richly through Jesus Christ our Savior, so that being **justified by His grace** we might become heirs according to the hope of eternal life." Paul then goes on and insists "that those who have believed in God may be careful to **devote themselves to good works**." (emphasis added). Paul then concludes his thought with the words, "These things (good works) are excellent and profitable for people."

### An Outreach Vision

Unquestionably, this advice from Paul to Titus is still applicable today to the Church going through a world crisis! In fact, Titus 3:4-8 becomes the perfect vision for the Church going through a world crisis.

#### Show Faith Works!

In these three verses, Paul makes it clear that a) we are not saved by works; b) we are saved by grace alone through faith alone in Jesus Christ alone; c) and those who have faith are to be *devoted to doing good works*. To put this into Faith Lutheran Church parlance, *since we are the people of Faith, may we be careful to devote ourselves to Showing Faith Works*. For "these things are excellent and profitable for people."

Simply put, a Titus sized outreach vision is as simple as:

#### Show Faith Works!

Connecting the disconnected people of our communities so that they too might come and see faith really works.

It's all about **intentionally creating opportunities** for the disconnected **to see faith works** and to **hear** more about **why faith works**.

Does this mean that outreach is only about filling the pews? Not a chance. Love and service of our neighbors flow out of Jesus' love and service He has shown us. This is exactly why Paul could insist that those who believe be committed to doing good works. Our desire to "show faith works" really is a vision for discipleship, and not for financial gain or even to return to a pre-pandemic state. It's a vision to find and engage the disconnected so that they too might know Jesus and have the assurance of saving faith that comes with being a disciple of Jesus.

### An Outreach Plan

The Faith Outreach team started meeting in January 2021 to formulate a plan based on the Outreach Vision to reconnect with FLC's Members, Visitors, Neighbors, and Community. Out of those meetings, the team identified 21 opportunities that would present FLC with the opportunity to "Show Faith Works." Each item is presently being fleshed out to understand priorities, cost, timeline, resource requirements, and how to be intentional about creating discipleship opportunities. The following opportunities are listed in "timetable" possibility (short range to long range):

#### Members

1. Updated Compass Groups. Reinvigorating the Compass Groups is one of the simplest ways to reconnect disconnected Faith members as well as connecting new Faith members. After the materials are updated, a "Compass Group Fair" will be held on Sunday morning so that people in the congregation can see how to get involved. This same information will also be available on the website. Additionally, people who go through the new member classes will have the opportunity to see which Compass Groups are a good fit, or when possible, new groups will be formed out of the class.

2. **"Fruits of Faith" regular reports.** Faith is such an active congregation both locally and globally. However, very few people are actually in the know. The idea behind "Fruits of Faith" is to give a brief update, preferably by video, on Sunday mornings to keep the congregation abreast of all the exciting things happening. The videos will also find their way online to *Show Faith Works* to the greater community.

3. **Updated parenting Sunday morning classes.** The pandemic has been particularly hard on Faith's parents and families. This particular demographic is perhaps the "highest at-risk" for not returning back to church. In a sense, FLC is looking at rebuilding the family ministry. As with building any "school age ministry," the key is starting an excellent program at ground level for the youngest kids (see item #4). In order for this to work, however, FLC also has to have an excellent program for the parents.

4. **Updated children's Sunday morning classes.** One of the insights garnered from this pandemic is that parents are looking for quality children's ministries for their children. Almost every new family that has come to FLC during the pandemic spent at least a month watching our children's messages online. It was after they got to know us that way that they were comfortable enough with us to come and see for themselves. Updating the children's programs will cover not only recruiting and training new teachers, but also entering into the world of "promotions" to get the word out to the disconnected.

Owner: Jonathan Loesch / Austin Angerman Target Date: Cost: 5. **Program to reconnect the disconnected members.** God has not been still during this pandemic. Many new people have "joined" FLC over the last year and now consider FLC to be their church home. However, many of the people "we used to see" regularly on a Sunday morning have drifted away. Worst case estimates are that we have lost an entire worship service of regular attenders. Realistic estimates are that 100+ members are now disconnected due to the pandemic (this estimate is based on our "regulars" who fill out attendance cards either in-person or online - the assumption here being that those who don't fill out either are normalized like they were pre-covid). While calling these disconnected members is a worthy start, the idea here is to be prepared to give them a reason to reconnect.

### Visitors

1. **Update website.** FLC's existing website has been a huge blessing to the congregation, countless visitors over the last three years, and now to many online guests. However, in terms of "web time," it's time for an update, especially with an eye toward the visitor. New graphics and inviting language is a must for helping those who are researching FLC find the information they are looking for. The website really has become the first "introduction" and "impression" of who FLC is. Furthermore, as the reputation of FLC starts growing with our neighbors and the community, the website will also become the portal for the community to see what is going on at FLC.

2. **Build a database of "interest".** In a sense, this is like a huge "Ministry Fair" of opportunities for anyone coming to FLC. If one was to "analyze" what it's like to visit FLC one would discover that we do a fantastic job welcoming people to FLC. The greeting team and ushering teams are par excellence (even during a pandemic!). However, following the worship service it is painfully obvious that visitors are left to their own devices to figure out what is next. Yes, there is a "Welcome Center" that is always staffed with the friendliest and helpful volunteers available and that is a key component to connecting with visitors. But this additional "database of interest" will become instrumental in "advertising" to visitors that there is so much more. This will allow us to leverage the screens and signage to make it easier for visitors to see how to get involved.

If you have ever invited anyone to a Bible class on Sunday morning, or even to church you know how difficult it is to explain the campus without signs. To make it easier for visitors and our neighbors to find their way around campus we need new signage. This would include not only signs above each of the classrooms, but "campus maps" in the parking lot, new signs in the parking lot pointing to the Preschool, Sanctuary, etc. *Owner: Andrew Rentschler*

4. **Update the FLC sign on Williams Drive.** FLC is one of the most beautiful churches in all of Georgetown, and it's one of the most invisible ones too. A lot of this has to do with the city of Georgetown and it's sign regulations. In order to "advertise" an event, the group hosting the event has to request permission to put up a sign. When permission is granted it comes with all kinds of stipulations about how far back and where the sign can be. Effectively, making sure the sign is still invisible. The idea here is to research how to update the existing FLC sign so that it can be used to communicate in a way that can be (will be) seen as people are driving by. *Owner: Lance Kroesch*

5. **Renovate the "narthex" into a "lobby."** FLC is blessed to have such an accessible and usable narthex. From a visitor's perspective, especially ones who did not grow up in a traditional church, the narthex is unlike anything they would expect. Most people are used to hotel lobbies or convention centers where the idea of the lobby is to have an inviting space that invites the visitor in and allows them to easily navigate to a place they want to be. Furthermore, updating the narthex into a lobby would create a space for after church where people could have fellowship time around coffee and food and engage the visitors.

### Neighbors

Brews and Views. Given that FLC, for good reasons, has a strict "no alcohol on FLC grounds" policy, this outreach opportunity probably seems strange. However, it is also true that FLC has its own brewery (technically the brewery owner attends Faith, so practically the same thing). It's also true that the younger generation is very open to real conversations around real good brews. The idea here is to research how to start new Compass Groups at the brewery around living in the real world, where God's Word intersects real life.

Owner: Eric Silber Target Date: Cost: 2. **Parent's night out.** One of the biggest mission field opportunities sitting right in front of FLC is the FLC preschool. Each year, dozens of preschool families do not have a church affiliation. There are so many possibilities to engage this community, ranging from Sunday morning participation, offering MOPS style classes for the moms, offering financial coaching for the families, etc. The first step, however, is to build a relationship with the parents. One of the simplest ways to do that is to periodically offer a "Parent's night out," where for a certain amount of time we look out after their kids so they can have a break. This then becomes one of the first steps in helping the parents get to know us, but also us getting to know them. *Owner: Janet Templeman* 

*Target Date: Cost:* 

3. **Seasonal events and activities.** Because of the pandemic, FLC had to postpone all scheduled outreach events including the Easter Eggstravaganza, Car Show, and Fall Festival. The Easter Eggstravaganza has also been canceled for '21. This, while very sad, creates the perfect opportunity to re-evaluate how FLC does these events. Heretofore, these events have been awesome! However, the events have not historically had much success in creating opportunities to serve the participants beyond the event. Meaning, there was no intentional effort being made to connect with the people beyond the event proper. The idea here is to develop a follow up program (see the Holy Smokers below) to engage the visitors on the next level. Additionally, part of this planning will be to dream up new activities for FLC to offer to our neighbors. *Owner: Chris & Janet Templeman*

4. **Fire up the Holy Smokers.** It is no secret that the Elders and Trustees of FLC like to smoke - that is, fire up the smokers out back and serve up lots of food. What better way to create an opportunity to invite the neighbors back on campus, much like a block party, after one of the major events that has happened on campus. Here new promotional material would be geared toward inviting people in (not necessarily showcase FLC programs - they can get all that on the website). Instead, the focus would be to meet them where they are, as opposed to trying to get them to meet us where we are. Next steps would be inviting them back to the last item on the Community list, the Olive Branch.

Owner: Eric Silber Target Date: Cost: 5. **Church plant within the church.** FLC consistently offers one of the most sacred and God honoring traditional worship services in the Georgetown area. Before covid, FLC alternated between Divine Services 1, 2, and 4 with traditional *Creative Worship* services in between. This is definitely a draw for anyone familiar with traditional worship. Surprisingly, it's also a draw for many of the younger generation who are seeking a deeper connection with the ancient future. There are many, arguably a majority, of our neighbors, however, that are not connected to this form of worship. The idea behind the "Church plant within the church" is to start a new church service on Saturday evenings that is uniquely Lutheran, but accessible to those who are not traditional Christians. One possible venue would be an updated Activity Center. The music would be more eclectic. The language would be simpler and more understandable to the newcomer.

### Community

1. Local missions serving our community. Historically, FLC has been extremely active in mission giving to the Texas District. This work is simply amazing. During the pandemic, however, the level of giving to the District had to be cut back due to the impact of the pandemic on giving. This, ironically, opened the door for the people of FLC to get involved in local missions. The first wave of local mission options being researched include: Habitat for Humanity, Rock House, Pen Pals, New Life Children's Center, Head Start, Williamson County Children's Advocacy Center, Helping Hands of Georgetown, local yard cleanup, etc. After the initial assessments are done and the top missions are identified, the missions team will hold "Missions Fair" Sunday to build a larger mission team for the project. Upon successful completion of the mission, the team will report back to the congregation and begin the process of looking for the next mission.

2. **Mission of the month.** This is different from the "Local missions" mentioned above in that this is a way of encouraging "loving the community." The idea is that the loose plate offering from the last Sunday of the month would be designated for missions and given to either a Compass Group, or the Youth Group, or any group to go out into the community and give something away. This could be as simple as handing out gift cards to the needy, or buying lunches, or addressing some community need.

4. **Stock the local food bank.** There is no denying the heart of FLC toward the community. Even without much ado about the Carrying Place Barrel, the barrel filled up with all kinds of food products to help those in need. Unfortunately, the Carrying Place has stopped collecting food via the barrels due to covid. The need, however, is still there. The idea behind this "mission" is to collect food and essential needs for the community and distribute them to the distributors that already have a relationship with those in need.

5. Live Nativity Scene. Part of the difficulty with connecting with the community is that the community doesn't even know that FLC exists. One of the simplest remedies for this is to host a live Nativity scene on Christmas Eve and then a lit-up Nativity from Christmas Day to Epiphany Day. Not only does this help the community "see" FLC, it also creates another connection point as they ask the question, "Why haven't they taken down their Christmas? Christmas is over." Yet another reason to visit our website and see what's up with FLC.
